

# PJC's First Capital Campaign Off to a Sterling Start

ess than a year into its first Capital Campaign, Lthe Pensacola Junior College Foundation is pleased to announce that 52 percent of the \$4.5 million goal has already been reached. Pledges and gifts in excess of \$2.3 million are an early indication of the widespread enthusiasm and support which the campaign is generating.

PJC's Board of Trustees and the Foundation's Campaign Cabinet initiated the Building on Tradition—Investing in the Future campaign last December with 100 percent participation in giving. Within a few months, PJC employees had surpassed their challenge goal of \$125,000, and to date have contributed more than \$175,000.

Locally, the Switzer and Reilly families, descendants of the late Anna Lamar Switzer, set the pace for the campaign with an unprecedented \$1 million gift. Their generous contribution will enable the college to establish the Anna Lamar Switzer Center for Visual Arts. For years to come, the Switzer Center will provide an enriched and expanded cultural environment, a consistent funding source for stateof-the-art technology and equipment, exposure to national and international artists, and scholarships for deserving students.

As impressive as its beginning is, the Capital Campaign still needs community-wide participation to be successful. Consider the following points:

- Meeting the \$4.5 million goal is critical for ensuring that PJC's tradition of excellence is maintained in the future. As the cost of education continues to escalate, state and federal dollars for community colleges consistently have diminished. Private support provides a margin of excellence that tuition and tax support cannot offer.
- · Meeting the campaign goal during its designated time frame will allow various matching programs to parlay that \$4.5 million into as much as \$9 million.
- PJC has a long history of mindful and prudent stewardship of funds.
- PJC's research and long range plans indicate financial support is needed in several areas serving the community as well as the college.

For these reasons PJC invites those it serves—individuals, alumni, corporations and foundations—to participate in our first Capital Campaign and to assure that our 51-year tradition of providing topnotch educational opportunities continues into the new millenium.


### Visual Arts Center to be Named for Anna Lamar Switzer

The contribution was made in honor of the late Anna Lamar Switzer, a local patron of the arts and education, by her descendents: Dee Dee (Switzer) and Kevin Reilly Sr.; Janie and Robert Switzer; Fran and Charles Switzer; Mary Ann and John Switzer;

Mary (Switzer) and Gordon L o u g h; Winifred and Kevin Reilly Jr.; Jennifer and Sean Reilly; Anna (Reilly) and Matt Cullinan; and Mary and Wendell Reilly.

The gift will be combined with college funds and state match dollars to fund the

will provide full two-year scholarships for outstanding students who display great promise in the arts.

An integral part of the Anna Lamar Switzer Center for Visual Arts will be a Community Liaison Panel. This group of

leaders in the local art community will serve as a communication link to the college regarding the community's needs.

"This gift will make an enormous difference in what the college can provide to students of the visual arts as well as to the community at large," said Allan Peterson, Visual Arts Department chair and Gallery director.

#### Anna Lamar Switzer

Anna Ashley Lamar was born in Valdosta, Ga. On Sept 11, 1900. Her parents, Caroline (Varnedoe) and Charles Lamar, moved their family to Pensacola in 1903 and soon founded what would become Lamar Outdoor Advertising. She attended the Armstrong School in Pensacola, the Lucy Cobb Institute in Georgia, and the Hartridge School in New Jersey.

Anna Ashley Lamar married Wendell Switzer in 1924 and traveled extensively during her husband's 45-year career in the U.S. Navy. When Vice Admiral Switzer retired, they moved to Pensacola where she continued her close association with the Navy and became a community activist.

Mrs. Switzer was the first woman named to the Naval **Aviation Museum** Foundation board, and was a life member of the Pensacola Historical Society, a past president of the Pensacola Art Association, and an honorary trustee of the Pensacola Museum of Art. She wrote The Lamar Heritage, published in 1972.



Admiral and Mrs. Switzer lost two sons in Naval aviation accidents, Lt. j.g. Wendell Switzer Jr. in 1955 and Lt. Cmdr. John Lamar Switzer in 1959. Admiral Switzer died in 1970. Anna Switzer died March 27, 1998, and is buried in Arlington National Cemetery with her husband and sons.



#### PJC Initiates Distinguished Artist Series With Architect Michael Graves

Award winning architect Michael Graves will be the inaugural speaker for the Anna Lamar Switzer Distinguished Artist Series at Pensacola Junior College. Graves will present "Telling Stories," an historical overview of architecture, at 7:30 p.m. on Friday, Oct. 29, in the Ashmore Fine Arts Auditorium.

Named for the late Anna Lamar Switzer, an avid patron of the arts, the Distinguished Artist Series will regularly bring acclaimed artists and scholars to the college and community as guest lecturers.

Graves has been in the forefront of architectural design since the beginning of his practice in 1964, winning more than 100 prestigious awards for his designs in architecture, interiors, products, and graphics.

Among his 200 design projects are the corporate headquarters for Humana and the Disney Company, the Newark Museum, and the Washington Monument Restoration scaffolding, as well as major projects in Europe and the Far East.

Graves is also well known for his design of furniture, furnishings, and artifacts, many of which are marketed under the trademark "Graves Design."

## **Ami-Lee Wilder Memorial Scholarship**

Virginia Rush, the first recipient of the Ami-Lee Wilder Memorial Scholarship Endowment, recently graduated from PJC. Rush says the scholarship allowed her to return to PJC after dropping out of her college classes several years earlier to go to work.

The scholarship endowment was established in 1991 in memory of Ami-Lee Wilder who was a student at PJC at the time of her death. Since Ami-Lee was a member of Phi Theta Kappa Honor Society, the scholarship is generally awarded to an honor student.

Funds for the scholarship are provided by an endowment established by family and friends of Ami-Lee. The Liberty Sertoma Club, of which Ami's mother is a member, sponsors a golf tournament in Ami-Lee's name each year to raise funds for the scholarship.

As the endowment has grown, three more scholarship recipients have been added.

#### Chadbourne Foundation Endowed Scholarship for Engineering

This scholarship is generally awarded to a deserving second year student enrolled full time in the A.S. Civil Engineering Technology Program or the A.A. Pre-Engineering Program.

Since the endowment has grown, this scholarship now is granted to two recipients.

#### Charles M. Hardin Memorial Scholarship

Nicholas Angelo and Lynn Burris II, are recent recipients of the Charles M. Hardin Memorial Scholarship.

The scholarship endowment was established in memory of Charles M. Hardin, who had been a member of the Jazz Society of Pensacola. The scholarship is awarded to a deserving full time music student involved in PJC's Wind Ensemble and Jazz Ensemble.

The Jazz Society of Pensacola (JSOP) provides funds for the scholarship. JSOP is an organization of musicians, teachers, students and "listeners" working to advance jazz music. Besides awarding scholarships to outstanding students, JSOP also sponsors music programs in the public schools, jazz concerts throughout the year, and public access TV jazz shows. JSOP is founder and supporter of the Pensacola Jazz Fest and Pensacola Jazz Party.

## M.J. Menge Bell Tower Dedicated During 50th Anniversary Events

Ahighlight of PJC's 50th Anniversary events was the dedication of the M. J. Menge Bell Tower on the Pensacola campus, April 17.

PJC students, staff, alumni and friends of the college gathered for ceremonies honoring Pensacola attorney M.J. Menge for whom the tower is named. A dedicated leader and PJC alumnus, Menge is recognized for his commitment to higher education in Northwest Florida and for his contributions to a variety of beneficial projects and activities in the community.

The tower dedication also included placement of a time capsule holding PJC documents and memorabilia. The capsule is scheduled to be unsealed on PJC's 100th anniversary, Sept. 8, 2048.
