# **Community Support Puts Capital Campaign Over the Top**

YES! Success! We did it!

No matter how you look at the figures, the result is something to crow about.

The PJC Foundation's first Capital Campaign is an overwhelming success, totaling more than \$5 million in gifts and pledges.

In addition, PJC could receive as much as \$3.8 million in state matching funds and approximately \$2 million in federal matching funds, bringing the campaign total to more than \$10 million.

The state matching funds are designated for scholarships, endowed chairs, facilities and equipment. The federal matching funds are earmarked for the upcoming WSRE digital conversion.

"When we began talking about this campaign two years ago, arriving at a list of bona fide needs was easy. Getting the courage to set an ambitious goal of \$4.5 million was not so easy," said PJC President Charles Atwell.

In fact, the consulting firm that conducted the feasibility study reported that in spite of PJC's positive community image, the goal likely could not be met.

"They just did not see how hard we were willing to work, how dedicated and committed our volunteers turned out to be, and how much of a grassroots campaign this became," Atwell said.

From its precedent-setting lead gift of \$1 million in December 1998 to the victory celebration in August 2000, the Capital Campaign was embraced by the Northwest Florida community.

Nearly 750 different individuals, organizations and businesses participated in the fund drive, including more than 300 PJC faculty and staff.

"It has been heartwarming and gratifying to see such broad based support for the college," said Tommy Tait, Capital Campaign general chair. "We were fortunate to begin the campaign with an impressive lead gift, but it was the ground swell of support from all over that really put us over the top."

A quick look around PJC shows that the outstanding success of the *Building on Tradition—Investing in the Future* Capital Campaign is already evident.

- A top-notch string music program has begun at PJC.
- The PJC Honors program has been revived this fall with an entering class of 42 Bright Futures scholars.
- Nearly \$1 million has been added for additional scholarships.
- More than \$1 million is being spent on equipment, mostly related to technology and the health curricula.
- The first Anna Lamar Switzer Endowed Teaching Chair has been awarded.
- Two PJC art students are currently receiving Switzer Scholarships.
- Groundbreaking for the Anna Lamar Switzer Center for the Visual Arts is scheduled for January with occupancy planned for next fall.
- Construction of the new Health Sciences Building on the Warrington campus is scheduled to begin in January.



"Like many community college students, I went to PJC piecemeal. Occasionally I was a full-time student, but mostly I attended part-time, taking a lot of classes at night while I was working full time during the day. I do not think I

would have been able to get my associate's degree without this flexibility and I never felt that I was getting less of an education because I was a part-time student.

"A hallmark of PJC then and now is that it offers widespread access to a top quality education. I attribute, in large measure, where I am today to the opportunities I had at PJC."




"I know that Congressman Joe Scarborough is not in the audience because he's at the Hard Rock Café opening for Little Richard," Russell quipped.

#### **Scholarship Spotlight**

# ATHLETIC ADVANCEMENT UPDATE PIRATE BASEBALL FACILITIES NEED FACELIFT

Those who have visited other community colleges along the Gulf Coast do not doubt that PJC tops the list for having beautifully maintained grounds and buildings.

On the other hand, those who have attended baseball games at neighboring community colleges do not doubt that PJC's baseball facilities do not measure up.

"Our playing field is kept in good condition and we are very pleased with our new press box and stands," said Bill Hamilton, Athletic Director. "However, our dugouts, public restrooms and concession stand desperately need renovation.

"It is embarrassing during recruiting and it is embarrassing to host other teams and expect the players to use our old dugouts with no storage area and to have Port-A-Potties for our restrooms," Hamilton explained.

Plans have been made for a first class baseball facility and a Capital Campaign Athletic Advancement goal of \$250,000 was set for funding the baseball renovation, among others.

Although the total campaign goal was exceeded, the funds earmarked for Athletic Advancement fell short and fund raising in this area will continue.

LeRoy Collins served as governor during the formation of the Florida Community College System and was a strong community college supporter throughout his career. In celebrating the achievements of community college alumni, FACC pays simultaneous homage to the everlasting spirit of a man with the integrity and courage to do the right thing at the right time.

"PJC was the right opportunity for me at the right time," says Saxon. "It provided a great transition from high school to post-secondary education. Without question, any measure of success I enjoy today is largely due to my PJC experience."

A 1976 graduate of PJC, R. Michael Saxon is the caliber of community leader PJC produces. Saxon, Gulf Power Pensacola district manager, displays outstanding leadership not only in Northwest Florida economic development activities but in philanthropic activities as well.

He recently received the Richard L. McLaughlin Economic Development Volunteer of the Year award from the Florida Economic Development Council (FEDC) for outstanding leadership in economic development efforts. He is clearly one of the emerging leaders in

Northwest Florida, and was so recognized by the Pensacola Area Chamber of Commerce in 1998-99. Saxon also was mentioned in the April 2000 edition of Florida Trend as a "Person to Watch" in Northwest Florida.

As chairman of the Pensacola Area Chamber of Commerce Committee of 100, Saxon was instrumental in locating 13 new and expanding business projects, resulting in 1,642 new jobs and nearly \$107 million in new capital investments.

One of the most significant new business locations achieved under Saxon's guidance was Washington Mutual Finance with an initial employment of 300 and an \$11 million investment. Saxon then partnered PJC with Washington Mutual Finance to provide training for the new employees.

Saxon has certainly not forgotten the role of education as he serves on the boards of the Escambia County Foundation for Excellence in Education and the University of West Florida Advisory Committee as well as the PJC Board of Trustees.

#### Warren Thompson Receives First Switzer Endowed Teaching Chair

Warren Thompson, photography teacher in the PJC Visual Arts Department, is the first recipient of the Anna Lamar Switzer Endowed Teaching Chair.

As a three-year appointment, the chair provides \$4,500 per year with \$2,500 going to the faculty member and \$2,000 going to the project. Thompson's project, "Vanishing

"The chair provides wonderful recognition for our faculty and a great opportunity for them to complete projects that will help them in their careers," said Allan Peterson, Art Department head and Gallery director.

The Anna Lamar Switzer Endowed Teaching Chair is just one result of the \$1 million gift presented to PJC by the Switzer and Reilly families of Pensacola. It was given in honor of their mother and grandmother as the lead gift of the PJC Foundation's Capital Campaign.
