Works with Director, other College departments, vendors, and contractors to plan, implement, and manage major network and telecommunications projects.

Works with Director to logically plan, organize, direct, and evaluate equipment acquisition and retirement of network and telecommunications systems.

Troubleshoots issues to determine cause, and recommends and/or initiates corrective actions based on analysis and consideration of ramifications on systems at every layer of the OSI model within the College environment.

Performs system analysis of network and telecommunications performance to ensure optimum efficiency.

Implements and manages diverse network and telecommunications systems, including security monitoring systems, cloud systems, data center systems, virtualization systems, and VOIP systems.

Implements and configures network and telecommunications equipment such as switches, routers, firewalls, wireless controllers, network/telecomm-related servers, and server applications. Assists the Director with the purchasing process for equipment and services.

Works with vendors and contractors to install and/or modify network and/or telecommunications systems and applications.

Practices excellent customer service throughout the campus community and works closely with peers.

Responsible for knowing and conforming to all safety practices and regulations that apply to this specific area and position. Unsafe conditions should be reported to the immediate supervisor and to the Pensacola State College Police Department/Public Safety.

Performs other duties as may be assigned.

## **Essential Functions:**

Analyze complex problems that affect diverse systems at all layers of the OSI model and implement solutions within the framework of and in cooperation with other ITS departmental units and other College faculty and staff.

Demonstrate effective verbal and written communication skills.

Use sound judgment and discretion to make decisions affecting operations and services.

Establish and maintain effective working relationships with Director, networking staff, other College departments and faculty.

Create written documentation and diagrams as required.

Work flexible hours, including weekends and evenings when necessary.

In-district travel to include all campuses and centers, and possible out-of-district overnight travel.

**Minimum Qualifications:** Graduation from a regionally accredited institution with a bachelor's degree in system science, information systems, networking, or related field and three years full-time progressively responsible experience in network and/or telecommunications that includes cabling, routing, switching, wireless networking, information security, network traffic management, network analysis and design. Experience with server operating systems, server application management, application programming and scripting, virtualization, and cloud systems. Experience with configuration of TCP/IP services such as DHCP, DNS, SMTP, LDAP, Web services, etc. Progressively responsible experience as described may be substituted on a year-for-year basis for the required education. A valid driver's license is required. Successful results of a criminal background check are required.

Pursuant to College policy, it is an employment eligibility requirement for an applicant to meet the requirements of § 435.04(2), Florida Statutes, related to background investigations. Any person failing to meet the requirements of the statute will be deemed not qualified to hold employment in this position. A Florida Department of Law Enforcement (FDLE) approved background check will be conducted on every successful candidate as a condition of employment, and any person who fails to disclose any adverse information contained in the background investigation at the time of submitting the employment application will be disqualified from employment.

**Preferred Qualifications:** Experience with Cisco switches, routers, firewalls, wireless controllers, Aruba wireless, Palo Alto firewalls, ShoreTel VOIP systems, traditional analog phone systems, Linux and Windows Server OS's, workstation OS's and diverse applications in a small- to medium-sized enterprise. Possess strong analytical skills in order to assess and solve problems in a complex environment.

**Physical Demands**: The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions. While performing the duties of this job, the employee must regularly lift and/or move up to 25 pounds, frequently lift and/or move up to 50 pounds, and occasionally lift and/or move up to 100 pounds.
