- A grade of D or higher in AMH 2010, AMH 2020, or POS 2041 is required to satisfy the Civic Literacy course requirement; a grade of C or higher in AMH 2010, AMH 2020, or POS 2041 satisfies the Civic Literacy course requirement and 3 credit hours of the 12-credit hour Writing Emphasis requirement. If the student retakes the course, the higher grade will be used.
- Any student with transfer credit from an in-state private college or university or any out-of-state college or university is considered “initially entering.”
- Any student with transfer credit from an FCS or SUS institution is not considered “initially entering.”
- The minimum passing score for the FCLE is 60% (48 correct answers out of 80 questions).
- Beginning in 2021-2022, the FCLE is required for all high school students enrolled in a high school U.S. Government course. A passing score on the FCLE meets the post-secondary Civic Literacy Assessment requirement.

**DEVELOPMENTAL EDUCATION EXEMPTION****Florida Statute 1008.30 and Rule 6A-10.0315**

The students below are not required to be assessed for college-readiness for communication and computation:

- A student who began 9<sup>th</sup> grade in a Florida public school in the 2003-2004 school year, or any year thereafter, and earned a standard high school diploma;
- A student who is an active-duty member of any branch of the United States Armed Services;
- A transfer student who earned a C or better in an approved college-level mathematics or English course from a regionally accredited school; this student is exempt from placement testing for the area(s), computation or communication, in which the C or better was earned; and
- A student who achieved the appropriate college-level scores on an approved common placement test within the last two years.

**FOREIGN LANGUAGE REQUIREMENT****Florida Statute 1007.262 and Rule 6A-10.02412**

- Applies to students initially entering the FCS or SUS Fall 2014 and beyond.
- Can be met with 2 credits of sequential foreign language in high school or with an earned grade of D or higher in a level 2 college foreign language course.
- AP, AICE, IB, DLPT, or CLEP tests (approved by the FLDOE Articulation Coordinating Committee) can be used for this requirement.
- A Departmental Exemption Exam is available for Spanish. Contact the Department Head for Humanities & Social Sciences (\$40 fee).

**GPA REQUIREMENT****Rule 6A-10.024**

- Students must have a cumulative grade point average of 2.0 or higher. In some circumstances, a different GPA of at least 2.0, such as the program of study GPA may be used to satisfy this requirement.

**RESIDENCY REQUIREMENT**

- Students must complete 25% of the required program credits at Pensacola State College, which can be taken in any delivery mode.

**COLLEGE-LEVEL COMMUNICATION AND COMPUTATION SKILLS REQUIREMENT (Gordon Rule)****Rule 6A-10.030**

- Prior to receipt of an AA degree or prior to entry into the upper division, a student must complete, with a grade of C or higher, six (6) semester hours of English coursework and six (6) additional semester hours of writing emphasis coursework as well as six (6) semester hours of mathematics coursework at the college algebra level or higher.

- A student who demonstrates readiness by achieving or exceeding standard test scores and enrolls in a Florida College System institution within two (2) years after achieving such scores shall **not** be required to retest or complete developmental education at a Florida College System institution.
