A notarized copy of your valid, unexpired government-issued photo identification is required. Military IDs are not acceptable forms of identification as photocopying of military identification cards and common access cards (CAC) is prohibited by law.

Identity and Statement of Educational Purpose (To Be Signed at the Institution)
