1. Tuition and fees are based on 12 credits for average full-time enrollment X 2 semesters = 24 credits. In-State Rate = \$104.58; Alabama Resident Rate = \$114.58; and Out-of-State Rate = \$419.76.
2. Books and supplies based on average new, rental, used or digital books plus supplies per semester for full-time enrollment.
3. The Living Expenses budget for a dependent student is calculated as \$524.90/month for ten (10) months plus an additional amount of \$21/day for 7 days per week for all weeks of instructions for meals. The Living Expenses budget for an independent student is calculated at \$1258/month for average rent in PSC area at ten (10) months plus an additional amount of \$21/day for 7 days per week for all weeks of instruction for meals.
4. Transportation based on 30 miles round trip X 4 days per week X 32 weeks at 58.5 cents per mile (rounded down).
5. Miscellaneous personal expenses based on estimated average expenses for personal hygiene items, clothing, recreation and entertainment.
