Important Questions	Answers	Why This Matters:
What is the overall deductible?	In-Network: \$3,500 Per Person/\$3,500 Family. <u>Out-of-Network</u> : \$10,000 Per Person/\$10,000 Family.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the policy, the overall family <u>deductible</u> must be met before the <u>plan</u> begins to pay.
Are there services covered before you meet your deductible?	Yes. <u>Preventive care</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive services</u> without <u>cost sharing</u> and before you meet your <u>deductible</u> . Are there other deductibles for specific services?	Yes. \$500 <u>Out-of-Network</u> Per Admission <u>Deductible</u> . There are no other specific <u>deductibles</u> . What is the <u>out-of-pocket</u> <u>limit</u> for this <u>plan</u> ?	Yes. In-Network: \$6,850 Per Person/\$9,000 Family. Out-Of- Network: \$18,000 Per Person/\$18,000 Family.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. Does this <u>plan</u> provide <u>Minimum Essential Coverage</u>? Yes
