**Course Description:** Surveys basic economic principles, concepts, and institutions that comprise the American economic system, examines how well the system operates, demonstrates the development of economic measuring devices, and outlines potential policies to keep the economy operating effectively. Offers some consideration to the development of economic concepts that treat mainly macro theory.

#### **Instructor Requirements:**

- Students are required to take 3 exams, complete chapter assignments on McGraw Hill (MH) Connect, attend lectures regularly and participate in class.
- Exams: We will have 3 exams in the course. The focus of the exam questions will be the material covered in the lectures, MH Connect assignments, and any handouts and worksheets.
  - Test 1 covers chapters 1, 2, 3 and 7
  - Test 2 covers chapters 9, 12, 13, and 14
  - Test 3 covers chapters 15, 17, 20 and 21
- MH Connect Assignments: Each chapter will have a MH Connect assignment. Students are to answer all practice questions on Connect until 80% is achieved correctly.
- Writing Assignments and Formatting: Written assignments should be in legible, or computer typed written format. MLA, APA, and Turabian are acceptable formats for citations in written works.
- Attendance Policies: Students are expected to attend class meetings and participate in class. Attendance will be recorded at each class meeting. Students will receive a grade for attendance.

- Describe the theories and problems of international trade, balance payments and exchange rates.
