A survey of music from the Middle Ages to the present, introducing the student to various types of music through the use of recordings. No previous musical experience necessary.

Definition: Critical thinking is evaluating the validity of both personal and shared ideas according to logically consistent standards.

Outcome: The student evaluates the validity of ideas, developing informed opinions or defensible conclusions.

- The student explains an issue, problem, event, or argument.
- The student articulates a position (perspective or thesis/hypothesis).

II. Communication

Definition: Communication is the imparting or interchanging of thoughts, opinions, or information.

Outcome: The student effectively communicates knowledge and ideas.

- The student understands context of and purpose for task with main idea, thesis, or message.

V. Cultural Literacy

Definition: Cultural literacy is knowledge of the histories, contributions, and perspectives of diverse cultures.

Outcome: The student demonstrates an understanding of human culture and its diversity.

- The student compares and evaluates the form, cultural context, and aesthetic qualities of artistic genre and movements.
- The student demonstrates awareness of culture.
- The student demonstrates awareness of history and its impact.

Course Learning Outcomes:

Successful students will demonstrate an understanding of:

1. The basic elements of music (harmony, melody, rhythm, and timbre, etc.).
2. The functional roles of music in Western societies.
3. The chronological and musical development of Western music.
4. The characteristics of Western music.

Methods of Evaluation

Tests: Four equal 100-point tests. No make up tests will be given; students will take tests they have missed along with the last test. Each test will comprise 25% of the final grade.

Listening Requirement: Listening is an essential part of this course. Therefore, each student is expected to devote adequate time listening to those recorded musical compositions which have been assigned. All of the tests except the first will contain a listening section.

Class Attendance: Absences will not be counted against the student. However, missing class will adversely affect the student's ability to complete assignments. It is the responsibility of the student to withdraw from the course if necessary.

Classroom Etiquette: Please turn off or silence cell phones. If you need to make or answer an emergency call, or read or send text messages, please excuse yourself from the classroom. Please use the back door if entering or leaving the classroom once we have begun.

Concert Attendance: All students will be required to attend a minimum of THREE live, musical performances chosen from an approved list. Failure to meet this requirement means a lowering of a student's grade by one letter for each concert/performance below the required three.

Students may earn Extra Credit by attending two performances (also from the approved list) beyond the requirement. Students will receive 5 points for the first extra performance and 5 points for the second performance. All extra credit points will be added to the student's final average.

Also note (!) the concerts where limited free tickets are available. Tickets will be available three weeks before the event at the Lyceum ticket office in Building 8. You must sign in at the beginning of the concert and sign out at the end of the concert with the Lyceum assistant who will be stationed at the entrance of the performance hall.
