Course Description: Surveys basic economic principles, concepts, and institutions that comprise the American economic system, examines how well the system operates, demonstrates the development of economic measuring devices, and outlines potential policies to keep the economy operating effectively. Offers some consideration to the development of economic concepts that treat mainly macro theory.

Course Requirements: Students are required to complete 5 exams, 20 Connect Homework assignments, a Critical Thinking Essay, a Global Learning Assignment, and attend lectures regularly.

- Exams: We will have 5 exams in this course, 1 for each module as listed in Canvas. The exams will be multiple choice and completed in class. The focus of the exam questions will be the material covered in the lectures. Each Exam is worth 100 points.
 - Exam 1: Covers Module 1 (Chapters 1, 2, 3, 4, 5)
 - Exam 2: Covers Module 2 (Chapters 7, 8, 9)
 - Exam 3: Covers Module 3 (Chapters 10, 11, 12, 13)
 - Exam 4: Covers Module 4 (Chapters 14, 15, 16, 18)
 - Exam 5: Covers Module 5 (Chapters 19, 20, 21)
- Connect Homework: We will have 20 Connect Homework assignments accessible on Canvas. These
 assignments have unlimited attempts and are 10 questions multiple choices to provide you a chance to
 practice studying the material for the exams. Each chapter will have a Connect Homework except
 Chapter 7. Each Connect Homework is worth 10 points.
- Critical Thinking Assignment: During Module 3, students will finish learning about the leading
 macroeconomic theories on the business cycle. Students will present a 500-word essay assessing the
 strengths and weaknesses of each theory. This will ensure that students obtain a basic understanding
 of the required material and to assist in the developing of critical thinking skills. This essay is worth 50
 points.
- Global Learning Assignment: Students will complete a GLA as part of the general education course requirements. The student will analyze, evaluate, and if necessary, challenge the validity of ideas, principles, and data in order to develop an informed opinion, probable prediction, and defensible conclusion. This will be done in a 300-word essay.
- Attendance: Regular class attendance and consistent class participation are significant factors that
 promote student success. Attendance is necessary to acquire the required course competencies,
 therefore regular and punctual attendance in class is required. Students who miss class for any reason
 are responsible for any material covered and any information given by the professor that day.

Grading Policy: There are 850 total possible points to earn within this course.

- Exams: 5 Exams each worth 100 points (500 total points)
- Connect Homework: 20 Connect Assignments each worth 10 points (200 total points)
- Critical Thinking Essay: 1 essay worth 50 points (50 total points)
- Global Learning Assignment: 1 essay worth 50 points (50 total points)

Attendance: Each missed day beyond the first three absences results in a deduction of 10 points (50 total points available)
