Special Requirements:

Writing Emphasis Requirement: A minimum of three fully developed, multi-paragraph, evaluated writing assignments, not including a final examination, are required.

Writing Emphasis Requirement: Instructors provide detailed feedback regarding the content, organization, and use of standard written English for each evaluated writing assignment.

Writing Emphasis Requirement: Instructors return each evaluated writing assignment to a student before submission of the next evaluated writing assignment.

Writing Emphasis Requirement: Only individual student work may count toward the minimum three evaluated writing assignments.

Writing Emphasis Requirement: Grading rubrics will be used for each evaluated writing assignment. These rubrics will be shared with each student.

Writing Emphasis Requirement: The grades earned on the writing assignments must reflect student performance in college-level writing and significantly impact the final course grade.

Methods of Evaluation:

At minimum, the instructor will cover content which aligns with statewide and institutional learning outcomes for the course. The instructor will measure student performance using the following:

This course will be graded on a points-based system. There are 100 points available in the course. Your final grade in the course is simply your total points earned out of 100. So, if you earned 80 points throughout the semester, then your final course grade (80/100) is a B (80%).

A note on participation points: All students begin the semester with 20 points for attendance and participation. Students can only lose these points throughout the semester by missing class and not completing in-class participation assignments. Students will lose 1 point for every participation assignment missed.

Instructor Policies

1) Attendance and Participation: Regular, punctual attendance is expected for face to face and live online classes. During each class period there will be an in-class participation assignment that students must submit by the end of the class period. Students must be present in the classroom in order to complete this assignment. If a student has an excused absence, then that student will be allowed to complete a make-up assignment. Otherwise, students will not be allowed to complete a make-up assignment. Otherwise, students will not be allowed to complete a make-up assignment. Excused absences will be left to the discretion of the instructor. Class disruptions, including (but not limited to) distracting use of technology or persistent talking while the instructor or another student is speaking, could result in losing a participation point for that class and being asked to leave the class.

2) Attention in the Classroom/Technology Policy: The only technology allowed in the classroom is a laptop computer in order to view the course readings and take notes. All other technology, such as cell phones, air pods, or headphones are not allowed in the classroom and should not be visible at any time. Students will initially be warned about violating the technology policy. However, continued violations of the technology policy will result in losing 1 point from the student's participation grade for each class period during which the violation takes place.

3) Late Submission Penalty for Explanatory Essays: If a student submits a late paper within 24 hours after the due date, then that student will lose 1 point on the assignment. After 24 hours, students will start losing 2 points per 24 hour period after the due date of an assignment.

Example: An Explanatory Essay is due Monday at 8am. If a student submits their paper after Monday at 8am but before Tuesday at 8am, then that student will only lose 1 point for a late submission. If a student submits their paper after Tuesday at 8am but before Wednesday at 8am, then that student will lose 3 points (1 + 2) for a late submission. If a student submits their paper after Wednesday at 8am but before Thursday at 8am, then that student will lose 5 points for a late submission (1+2+2). After 5 days, the student will not receive credit for the assignment.

4) Office Hours: I will be holding all of my office hours in my office in building 14 on the Pensacola campus (room 1481). Since this location may be inconvenient for students to show up in person, I will also be available via Zoom during my scheduled office hours. If students would like to meet via Zoom, then they should simply email me requesting a meeting.
