Course Description: In this course, students will learn the foundations of macroeconomics as the branch of economics concerned with how decision-making, in an environment of scarcity, maps onto the aggregate economy. Students will examine theories and evidence related to the following core set of topics: national income determination, money, monetary and fiscal policy, macroeconomic conditions, international trade and the balance of payments, and economic growth and development.

- 1. Define basic economic concepts and correctly apply economic terminology.
- 2. Measure and evaluate economic activity using national income accounts, inflations and unemployment, and summarize the causes and effects of economic growth.
- 3. Analyze national economic activity through the aggregate demand and supply model.
- 4. Evaluate the roles of money, banking and the financial sector in the national economy.
- 5. Evaluate and apply fiscal and monetary policies to economic situations.
- 6. Describe the theories and problems of international trade, balance payments and exchange rates.

Evaluations of student progress towards achieving the stated learning outcomes and performance objectives is the responsibility of the instructor, within the policies of the College and the department. Detailed explanations are included in the course supplementals developed by the instructor for each section being taught.

Course Requirements: Students are required to complete 5 exams, 20 Connect Homework assignments, a Critical Thinking Essay, a Global Learning Assignment, and attend lectures regularly.

- Exams: We will have 5 exams in this course, 1 for each module as listed in Canvas. The exams will be multiple choice and completed in class. The focus of the exam questions will be the material covered in the lectures. Each Exam is worth 100 points.
 - Exam 1: Covers Module 1 (Chapters 1, 2, 3, 4, 5)
 - o Exam 2: Covers Module 2 (Chapters 7, 8, 9)
 - Exam 3: Covers Module 3 (Chapters 10, 11, 12, 13, 17)
 - o **Exam 4:** Covers Module 4 (Chapters 14, 15, 16, 18)
 - o **Exam 5:** Covers Module 5 (Chapters 19, 20, 21)
- Connect Homework: We will have 20 Connect Homework assignments accessible on Canvas. These assignments have unlimited attempts and are 10 questions multiple choices to provide you a chance to practice studying the material for the exams. Each chapter will have a Connect Homework except Chapter 6. Each Connect Homework is worth 10 points.

- Critical Thinking Assignment: Throughout the class, students will identify a topic within macroeconomics that they believe poses a problem to society. They will proceed to construct an argument identifying (1) why society should be concerned about the problem, (2) what the root causes of the problem, using macroeconomic principles, and a (3) a package of solutions aimed at resolving the problem using data, principles, and critical thinking. They will then write a 1,000+ word essay consolidating these arguments into a structured format. This assignment will be worth a total of 100 points, 5 points will be awarded for the timely selection of a topic, 5 points shall be awarded for the timely formulation of a synopsis, and 90 points will be available for the essay itself.
- Global Learning Assignment: Students will complete a GLA as part of the general education course requirements. The student will analyze, evaluate, and if necessary, challenge the validity of ideas, principles, and data in order to develop an informed opinion, probable prediction, and defensible conclusion. This will be done in a 300-word essay.
- Attendance: Regular class attendance and consistent class participation are significant factors that promote student success. Attendance is necessary to acquire the required course competencies, therefore regular and punctual attendance in class is required. Students who miss class for any reason are responsible for any material covered and any information given by the professor that day.
- Extra Credit: There will be fifteen extra credit assignments (one for each week) that will be available throughout the semester. Each one will pose a question and require you to use critical thinking to apply the concepts were learned in this class to important issues within macroeconomics in essay format. Each weekly extra credit assignment is worth a possible 10 points, but are not required for successful completion of this course.

Grading Policy: There are 900 total possible points to earn within this course.

- Exams: 5 Exams each worth 100 points (500 total points)
- Connect Homework: 20 Connect Assignments each worth 10 points (200 total points)
- Critical Thinking Essay: 1 essay worth 100 points (100 total points)
- Global Learning Assignment: 1 essay worth 50 points (50 total points)
- Attendance: Each missed day beyond the first three absences results in a deduction of 10 points (50 total points available)
