Course Description: In the course, students will be assigned readings representative of a broad range of literary genres and cultures. These readings will cover a variety of literary movements and historical eras. The readings will include selections from the Western canon. Written analysis of literary works may be required. Students will be provided with opportunities to practice critical interpretation.

Prerequisites: Grade of C or better in ENC 1102.

Course Designations: College Transfer. Meets AA General Education Core, Humanities and Literature requirement. A writing emphasis course.

General Education Core Course Standard: Per Florida Statute 1007.25, "Humanities courses must afford students the ability to think critically through the mastering of subjects concerned with human culture, especially literature, history, art, music, and philosophy, and must include selections from the Western canon."

Course Learning Outcomes:

- 1. Use selected literary terms in oral and written discussion of literature from multiple genres.
- 1. Choose and apply appropriate rhetorical strategies in formal essays.
- 2. Produce fully developed, coherent multi-paragraph essays on literary topics.
- 3. Analyze selected works using critical reading skills.
- 4. Express convincing interpretations of selected literature.
- 5. Explain logical connections between literature and life experiences.

Course Specific Requirements:

- 1. Writing that includes textual analyses, reader's journals, independent research, and MLA documentation.
- 2. Oral participation that may range from participation in class discussion to formal presentations.
- 3. Tests, objective or essay, including a final exam based upon Course Learning Outcomes.

General Education Writing Emphasis Course Requirements:

- All writing used to fulfill the writing emphasis requirement must possess the five characteristics of college-level writing: 1) have a clearly identified central idea or thesis; 2) provide adequate support for the idea; 3) be organized clearly and logically; 4) show awareness of the conventions of standard written English; and 5) be formatted in an appropriate fashion for the assignment.
- 2. A minimum of four (4) evaluated assignments, which may include the final exam, is required. Because an extensive amount of writing is intended by Rule 6A-10.030, F.A.C., additional writing assignments may be used to satisfy this requirement.
- 3. The grades earned on the writing assignments must reflect student performance in college-level writing and significantly impact the final course grade.
- 4. All sections of a course must meet all requirements.
- 5. Instructors provide detailed feedback regarding the content, organization, and use of standard written English for all writing used to satisfy the requirement.
- 6. Instructors return each evaluated writing assignment to a student before the submission of the next evaluated writing assignment, with the exception of a final exam used to satisfy the requirement.
- 7. Only individual, original student work counts toward the extensive writing requirement; AI or machinewritten content is not accepted.
- 8. The grading rubrics used for each writing assignment will be shared with students and will be uniformly applied as the assessment instrument in all sections of a course.

At minimum, the instructor will cover content which aligns with statewide and institutional learning outcomes for the course. The instructor will measure student performance using the following:
