Course Description: A survey of the history of the American experience from 1877 to present. Emphasizes the growth of American industry and business and the social and economic reforms connected with that growth. Also emphasizes the emergence of the United States as a world power during the 20th century and the ramifications that rise has had on foreign and domestic policy.

Special Requirements:

Writing Emphasis Requirement: A minimum of three fully developed, multi-paragraph, evaluated writing assignments, not including a final examination, are required.

Writing Emphasis Requirement: Instructors provide detailed feedback regarding the content, organization, and use of standard written English for each evaluated writing assignment.

Writing Emphasis Requirement: Instructors return each evaluated writing assignment to a student before submission of the next evaluated writing assignment.

Writing Emphasis Requirement: Only individual student work may count toward the minimum three evaluated writing assignments.

Writing Emphasis Requirement: Grading rubrics will be used for each evaluated writing assignment. These rubrics will be shared with each student.

Writing Emphasis Requirement: The grades earned on the writing assignments must reflect student performance in college-level writing and significantly impact the final course grade.

Methods of Evaluation:

At minimum, the instructor will cover content which aligns with statewide and institutional learning outcomes for the course. The instructor will measure student performance using the following:

Method of Evaluation:

Module Quizzes:

- There will be a quiz in each Module of our course to provide formative (immediate) assessment.
- Each quiz will cover the information from the textbook reading and provided lectures of the specific Module.
- Each quiz may only be accessed once and must be completed within the 60-minute time limit.
- The Module Quizzes are due by 11:59 pm (CST) on Sunday of each Module.
 - See the Module Introduction/Objectives/Assignment for the quiz dates.
- The Module Quizzes are each worth 30 points and are 30% of your final grade.

Module Discussions:

- There will be a discussion board within each Module of our course. (Mid-Term week and Final Exam week we will not have a discussion board.)
- There are two post requirements throughout the week:
 - Initial Post: A post in which a response to the root discussion board question(s) is provided.
 - The Initial Post must include a <u>minimum of 300 words</u> that completely, clearly, and effectively respond to the root question.
 - Seamlessly apply the 5Ws of academic writing: Who, What, Where, When, and especially Why when constructing your Initial Post.
 - The Initial Post is due by 11:59pm on **Thursday** of each Module.
 - The Response Post: A post in which responds to a classmates' Initial post or response.
 - The Response Post must include a <u>minimum of 200 words</u> that completely, clearly, and effectively respond to your classmate's post to which you are responding.
 - Ask additional questions. Further elaborate on your classmate's post. Incorporate your related experiences.
 - Apply the 5Ws of academic writing: Who, What, Where, When, and especially Why when constructing your Response Post.
 - The Response Post is due by 11:59pm on **Sunday** of each Module.
- The Discussion Boards are worth 20 points per Module (10 pts per post type) and are 30% of your final grade.

Critical Analysis Essays:

- There will be three critical analysis essays in our course.
- The topic and additional instructions for each essay are provided in our course.
 - o Essay #1: Due 11:59pm on Sunday, May 26.
 - o Essay #2: Due 11:59pm on Sunday, June 9.
 - o Essay #3: Due 11:59pm on Sunday, June 23.
- Each Critical Analysis Essay will have a point value of 100 points.
- The Critical Analysis Essays are worth 30% of your final grade.

Final Exam:

- There will be a comprehensive Final Exam in our course.
- The exam will be based on the required readings, classroom discussions and lectures, and any additional material provided.
- The exam may include objective questions, short answer questions, and essay questions.
- The exam must be completed within the 2-hour time limit.
- The exam will have a point value of 100 points and is 10% of your final grade.
- The Final Exam will open on Sunday, June 23 and must be submitted by 11:59 pm (CST) on Tuesday, June 25.

Course Learning Outcomes:

- 1. Identify the key events in American history from the end of the Civil War to the present, including western expansion, the age of industry, the world conflicts of the 20th century, the Cold War, and the making of modern America.
- 2. Identify the individuals, groups, and various peoples who were instrumental in the growth and development of this country from the end of the Civil War to the present.
- 3. Trace the ideas, forces, and movements which made the United States a world power by the 20th century and explain how the United States responded to and participated in the global conflicts of the 20th century.
- Analyze the problems Americans experienced in western expansion, the rise of industry, immigration, the Great Depression, two world wars, the Cold War, and the problems modern America faces.
- 5. Evaluate and compare the key events from this period in American history, especially as relates to cause and effect, and apply those lessons learned.
- 6. Communicate, using critical thinking skills, the key events and players in this period of American history.
- 7. Develop and demonstrate an understanding of the basic principles and practices of American democracy and how they are applied in our republican form of government.
- 8. Develop and demonstrate an understanding of the United States Constitution and its application.

- 9. Develop and demonstrate knowledge of the founding documents and how they have shaped the nature and functions of our institutions of self-governance.
- Develop and demonstrate an understanding of landmark Supreme Court cases, landmark legislation, and landmark executive actions and their impact on law and society.
