## Methods of Evaluation:

Test Average and Forum Participation are calculated together to create a percentage grade. Here is a breakdown of how it all works:

**Forum Participation:** All students are required to post on the online Connect 4 Education course discussion forum once a week, for a total of 14 weeks. Each post should be at least <u>one paragraph in length</u> and all content must be related to music appreciation. Students are encouraged to create topics of their own, provided that they are course-related. Each student post will count as 1% of the student's final grade.

**Assessments:** On the online Connect 4 Education site, assessments are like quizzes and count towards the student's average test grade. Each assessment can only be taken once and the student is expected to study before taking it. Late assessments will have one letter grade deducted for every day the assessment is submitted past the due date. Scores are automatically calculated by the Connect 4 Education site and combined with the results of the midterm and final exam in the final test average.

**Tests:** The midterm and final exam will be due at the specific times listed under the OnMusic Appreciation course schedule. Scores for the midterm and final exam will be automatically calculated by the Online 4 Education site and combined with the results of the assessments in the final test average.

**Listening Requirement:** Listening is an essential part of this course. Therefore, each student is expected to devote adequate time to <u>actively</u> listening to the recorded musical compositions which have been assigned in the course. One listening run-through of each recording is not enough! Listening three times to a musical work is a good starting point, but it may be necessary to listen several more times. Remember, there is always something new to learn at each hearing, no matter how much experience a listener has.

**Concert Attendance:** All students will be required to attend <u>a minimum of THREE (3)</u> live, musical performances chosen from an approved list. Failure to meet this requirement means a lowering of the student's grade by one letter for each concert/performance below the required three.

**Extra Credit:** Students may earn extra credit by attendance at two performances (also from the approved list) beyond the requirement. Students will receive 5% towards their final grade for the first extra performance and 5% for the second extra performance. All extra credit will be added to the student's final grade.

**Notice!** There are concerts where limited free tickets are available. Tickets will be available three weeks before the event at the PSC Lyceum ticket office in Building 8 of the main campus. You must sign in at the beginning of the concert and sign out at the end of the concert with the official Lyceum monitor who will be stationed at the entrance of the performance hall. You must also fill out at least <u>ONE (1) Concert Report Form</u> and turn it in to your instructor before the last day of class.
