<b>Course Description</b>	This course introduces students to rhetorical concepts and audience-centered approaches to writing including composing processes, language conventions and style, and critical analysis and engagement with written texts and other forms of communication.

<b>Course Designations</b>	College Transfer. Meets AA General Education Core, Communications requirement. A writing emphasis course.

<b>Course Learning Outcomes</b>	<ol style="list-style-type: none"> <li>1. Students will apply rhetorical knowledge to communicate for a range of audiences and purposes.</li> <li>2. Students will employ critical thinking to analyze forms of communication.</li> <li>3. Students will engage in writing processes that involve drafting, revising, and reflecting</li> </ol>
<b>General Education Student Learning Outcomes</b>	<ol style="list-style-type: none"> <li>1. <b>Critical Thinking:</b> The student analyzes, evaluates, and, if necessary, challenges the validity of ideas, principles, or data in order to develop informed opinions, probable predictions, or defensible conclusions.</li> <li>2. <b>Communication:</b> The student effectively communicates knowledge and ideas.</li> <li>3. <b>Information Literacy:</b> The student effectively locates, evaluates, and applies information from a variety of sources.</li> </ol>
<b>General Education Writing Emphasis Course Requirements</b>	<ol style="list-style-type: none"> <li>1. All writing used to fulfill the writing emphasis requirement must possess the five characteristics of college-level writing: 1) have a clearly identified central idea or thesis; 2) provide adequate support for the idea; 3) be organized clearly and logically; 4) show awareness of the conventions of standard written English; and 5) be formatted in an appropriate fashion for the assignment.</li> <li>2. A minimum of four (4) evaluated assignments, which may include the final exam, is required. Because an extensive amount of writing is intended by Rule 6A-10.030, F.A.C., additional writing assignments may be used to satisfy this requirement.</li> <li>3. The grades earned on the writing assignments must reflect student performance in college-level writing and significantly impact the final course grade.</li> <li>4. All sections of a course must meet all requirements.</li> <li>5. Instructors provide detailed feedback regarding the content, organization, and use of standard written English for all writing used to satisfy the requirement.</li> <li>6. Instructors return each evaluated writing assignment to a student before the submission of the next evaluated writing assignment, with the exception of a final exam used to satisfy the requirement.</li> <li>7. Only individual, original student work counts toward the extensive writing requirement; AI or machine-written content is not accepted.</li> <li>8. The grading rubrics used for each writing assignment will be shared with students and will be uniformly applied as the assessment instrument in all sections of a course.</li> </ol>

Narrative Essay: The students will learn the skill of writing a personal story while learning that these stories often include characters, settings, plot, and climax.		10%	
Descriptive Essay: The students will learn to describe while using sensory details to create a vivid picture for the reader. Incorporating sight, sound, smell, touch, taste, and movement will help accomplish the most detailed mental picture for the reader.		10%	
Compare/Contrast Essay: This essay requires the student to explore the obvious and hidden similarities and differences between two subjects. Critical and analytical thinking is required to successfully write a compare/contrast essay.		10%	
Argumentative Essay: The students will choose a topic that is arguable and submit for approval. In a separate assignment, they will submit an outline (format of their choosing); on that same assignment, they will submit their three sources and cite them in MLA format for instructor approval.		15%	
Homework/Classwork: Assignments to include answering questions from readings during class time. This section also includes an assortment of short in-class writings.		10%	
Quizzes: Quizzed assignments will be from readings assigned.		10%

Participation: This will include staying on task for in-class assignments.		10%
