General Education Writing Emphasis Course Requirements	<ol style="list-style-type: none"> 1. All writing used to fulfill the writing emphasis requirement must possess the five characteristics of college-level writing: 1) have a clearly identified central idea or thesis; 2) provide adequate support for the idea; 3) be organized clearly and logically; 4) show awareness of the conventions of standard written English; and 5) be formatted in an appropriate fashion for the assignment. 2. A minimum of four (4) evaluated assignments, which may include the final exam, is required. Because an extensive amount of writing is intended by Rule 6A-10.030, F.A.C., additional writing assignments may be used to satisfy this requirement. 3. The grades earned on the writing assignments must reflect student performance in college-level writing and significantly impact the final course grade. 4. All sections of the course must meet all requirements. 5. Instructors provide detailed feedback regarding the content, organization, and use of standard written English for all writing used to satisfy the requirement. 6. Instructors return each evaluated writing assignment to a student before the submission of the next evaluated writing assignment, with the exception of a final exam used to satisfy the requirement. 7. Only individual, original student work counts toward the extensive writing requirement; AI or machine-written content is not accepted. 8. The grading rubrics used for each writing assignment will be shared with students and will be uniformly applied as the assessment instrument in all sections of a course.

<p>Writing Assignment – Operant Conditioning</p> <p>Operant conditioning is often discussed within the context of parenting or dog training, but it is a learning tool that is regularly used to shape adults' behavior as well.</p> <p>Identify three examples of operant conditioning that occur in the everyday lives of adults.</p> <p>You should also delineate the following for each instance of operant conditioning you discuss:</p> <ol style="list-style-type: none"> 1. the target behavior 2. the stimulus 3. the type of stimulus (positive vs negative & reinforcement vs punishment) 4. the schedule of reinforcement 	5%
<p>Writing Assignment – Article Analysis</p> <p>This assignment asks students to read Lipson et al.'s (2021) article "<i>Mental Health Conditions Among Community College Students: A National Study of Prevalence and Use of Treatment Services</i>" and answer comprehension and reflection questions. The task involves summarizing key research details, such as authors, participants, findings on prevalence, treatment barriers, and funding recommendations, and then writing thoughtful personal reflections that connect course concepts to real-world mental health observations and coping strategies.</p>	5%
<p>Writing Assignment – Psychological Disorders</p> <p>What IS a psychological disorder? Not even the American Psychological Association (APA) can agree to a definition that fits all of the disorders currently recognized within the DSM-V. Ultimately, the notion of disorderly thoughts and behaviors is inherently subjective. What one person may consider disorderly is perfectly normal, or even preferential, to another. Despite this, the psychologists tasked by the APA to determine what pattern of thoughts and behaviors will be</p>	5%

<p>recognized and treated as disorderly often use one set of criteria: deviance, dysfunction, distress, and danger.</p> <p>Select one of the APA-recognized disorders covered by your textbook and analyze if and how it meets the four criteria. Your analysis should be based on the thoughts and behaviors specific to your chosen disorder. If your disorder doesn't meet all of the 4 D's, why do you believe it is still considered a psychological disorder?</p>																								
<p>Writing Assignment – External Validity of Psychological Phenomena The field of psychology explores a wide array of topics. While some don't have much relevance outside academia, most areas of psychological study are relatable to our own experience in some way and can even provide us with insight that can improve our lives.</p> <p>Select three psychological phenomena/theories (e.g. general adaptation syndrome, actor-observer bias, etc.) discussed in your textbook that you found most impactful for you and your life, and detail how you have/could use what you learned regarding these topics to enhance your life.</p>	5%
