Course Description: An introduction to theatre as a collaborative art form through the critical analysis of its historical context, production, theory, and connections to theatrical literature, including the western canon. The student will explore dramatic structure, techniques, and various organizational elements. Designed to instill a curiosity and interest in all areas of the theatre. This is not an acting class.

Course Learning Outcomes:

Successful students will:

1. identify the basic principles of theatrical performance, design, technology, organization, and management.
2. assess the significance of the human condition as expressed through the performing arts.
3. explore and interpret works of art utilizing creative and critical thinking skills.
4. demonstrate college-level writing.
5. define, compare and contrast theater as both an expressive art form and a commercial industry.
6. demonstrate skills needed for critiquing a theatre performance
7. describe aspects of audience etiquette
8. describe the relationship between the architectural design of a theatre and the impact on audience perception
9. analyze the responsibilities of the actors, director, and playwright
10. discuss the impact of scenery, costuming, lighting, and sound
11. describe the difference between dramatic literature vs. other literary genres

Course Specific Requirements

1. Attendance is mandatory. Students must log on to the course at least twice a week and remain active and involved in the course (i.e. turning in assignments, participating in discussion boards, taking exams), for the remainder of the semester.
2. Class participation is an important part of the learning process and is therefore expected of each student. Throughout the semester there will be several course-related discussion topics. Participation in these discussion topics is mandatory.
3. The writing requirement will be an opportunity to improve skills in the organization and written expression of ideas. The live performance review assignment paper has been carefully chosen to aid students in meeting the objectives of this requirement.
4. An introductory exam, plus four unit of study exams will be used to assess subject matter comprehension.
5. You should consider all due dates and times as the **last possible opportunity** to submit an assignment. Work ahead of the class schedule so you do not miss a deadline.
6. ALL assignments must be completed and submitted on time. **Late work will not be accepted and will result in a grade of zero.**
7. **If you are required to be away from a computer on the day an assignment is due, you must turn it in early.**
8. The only exceptions to these rules occur when a student submits written verification of a death or life threatening emergency, or if you are representing the college in an official capacity on the date an assignment is due.
9. **Extra Credit is not available. Please keep up with the assignments and due dates.**
10. If unavoidable circumstances occur in your life that impede your performance in this course, please let me know!

Writing Assignment

The writing assignment for this course is a **critical review** of a live play emphasizing the areas of acting, directing, set design, costumes, etc. The approved live performance is posted in the Canvas Course site, as are the writing guidelines.
