ADVISORS CORNER

Summer and Fall registration are currently under way, as always, we recommend you make an appointment with an advisor as summer classes fill up quickly. For VA benefits in summer, you only require 8+ credit hours to be considered full time (3 classes most cases). If you are completing your degree for Spring Graduation you will need to apply via your WorkDay create request (see below). Our advisors are here to let you know what we have to offer our veteran population about Pensacola State College and class registrations.

If you are using VA benefits and a college program advisor or self-registration always follow up with one of our Veteran Student Advisors to confirm proper eligibility. As a reminder for NEW and current students if you have not requested your prior academic transcripts i.e., other colleges or institutions to include high school you can do so through your MyPSC apps Parchment. Students should check their Workday and student email accounts daily. We are looking forward to helping you with registration needs.

Transcript Requests: Visit Parchment by clicking the Parchment tile on MyPSC or Parchment's website and entering your email to set up your Learner Account. If there is an issue with your order, such as a hold, Parchment will email resolution instructions.

IMPORTANT VA HEALTH CARE UPDATE!

VA is expanding health care eligibility to millions of Veterans—including all Veterans who served in the Vietnam War, the Gulf War, Iraq, Afghanistan, or any other combat zone after 9/11—years earlier than called for by the PACT Act.

VA announced that all Veterans who were exposed to toxins and other hazards while serving in the military — at home or abroad — will be eligible to enroll directly in VA health care beginning March 5, 2024. This means that all Veterans who served in the Vietnam War, the Gulf War, Iraq, Afghanistan, the Global War on Terror, or any other combat zone after 9/11 will be eligible to enroll directly in VA health care without first applying for VA benefits. Additionally, Veterans who never deployed but were exposed to toxins or hazards while training or on active duty in the United States will also be eligible to enroll.

Personalized Career Planning and Guidance (PCPG)

Helping you reach your education and career goals



What is PCPG?

The Department of Veterans Affairs (VA) is here to support you as you face education and career decisions or transition from military to civilian life.

The Personalized Career Planning and Guidance (PCPG) program is a critical VA benefit that provides career counseling, assessment, education planning and guidance resources unique to your needs, and can help you set and achieve personal, career and education goals. It provides you with one-on-one support whenever you need it – putting you in the driver's seat of your education or career plan.

How can PCPG help you?

Counselors can provide tailored career planning and guidance to include:

- Career choice assistance to understand the best career options based on your interests and skills.
- Education/career counseling and a tailored training, education or employment plan.
- Academic and adjustment counseling to help you find solutions and ways to overcome any obstacles to your success.
- Benefits coaching to help you use other VA benefits and resources effectively, including your VA education benefits.
- Assistance with resume writing, interview skills, and more!

When should you access PCPG?

Consider using PCPG when:

- · Considering job or career options or going through employment changes
- Facing obstacles in accessing education and employment opportunities
- Ensuring your education benefits are used in the best way possible
- · Interested in, or currently pursing, higher education
- Transitioning from military to civilian life

You may benefit from using PCPG benefits more than once when making important education and career choices. Follow up sessions are available for as long as you remain eligible for the benefit.

Eligible participants can get support in a variety of ways – through in-person counseling or remotely by use of tele-counseling.

Who is Eligible for PCPG?



Transitioning Service members six months prior to separation



Veterans who have transitioned from active duty service in the last year



Any Veterans or beneficiaries eligible to utilize a VA educational benefit

How can you access PCPG resources?

APPLY ONLINE – Visit <u>VA.gov</u> to complete and submit your application.

APPLY BY MAIL – Fill out the application located at https://www.vba.va.gov/pubs/forms/VBA-25-8832-ARE.pdf and mail it to your local VA Regional Office.

APPLY IN PERSON at your local VA Regional Office or by visiting a VetSuccess On Campus (VSOC) office.

A representative will contact you once your application is received and you will be assigned a time to meet with a counselor.
