 Question: Do you have network diagram for your LAN & WAN for voice and data? Not at this time. If the College is able to generate one, we will provide through an additional addendum.
- Question: And do you have Total Economic Value of what you are paying out now?
- Response: The College does not have this information readily available.
- Question:Dunn and Bradstreet financial statement report is this a requirement for the bid?Response:If a Dunn and Bradstreet financial statement report is not available, proposers may submit their audited
financial statements.
- Question:How many phones in total are needed at all campuses?Response:See section 6.5 on page 18 for the estimated quantities of each type of device. The total is estimated at 2,245.
- Question:Is there a brand name that the college is requesting?Response:No
- Question:How much of the existing infrastructure will be used in the new implementation?Response:The College will undergo replacement of the old PBX system and newer LYNC system. The College does
have new POE switches on all campuses
- Question:Are we replacing/removing existing phones?Response:Yes, proposers will be replacing existing phones. With the proposal, vendors can submit any trade-in
options for existing phones.
- Question:Will the new vendor use the existing Cisco switches or will those need replacing?Response:All switches have recently been upgraded to Cisco POE.

Question:	Does the College have an interest in a (Unified Communications as a Service with a monthly all-inclusive service where the provider houses all of the common equipment in one or two of our class-5 data centers, and provides a full-featured UC solution as a monthly expense item, including all installation, training, maintenance & upkeep for the length of the contracted term?
Response:	Bidders can bid on this type of service. The College will review.
Question: Response:	Is this 60 month terms since CPE is involved? If bidders are submitting bids for a term, proposers shall indicate with their submission term options
Question:	 Will the RFP include or is there a separate RFP for the following: (4) PRI at main campus for local calls (1) PRI at main campus for long distance calls (1) each Tie T1 between Pensacola and Milton, and Pensacola and Warrington campuses

Question:	The only specifications I could find would be directed to the Current Equipment Section 2.2 2200 DID extensions/7 locations No specifications outlined on a per site basis. This would affect labor, PBX and networking equipment
Response:	quantities. College will respond through an additional addendum.
Question:	Vendors offer multiple phone types based on the work responsibilities of the individual. No requirements specified as to phone types and quantities per site
Response:	College will respond through an additional addendum.
Question:	2.2 Current Environment outlines 300 phones partially deployedWhat does partially deployed mean?Are these phones spread across multiple locations?
Response:	College will respond through an additional addendum.
Question: Response:	Call Center functionality and training requested in 6.7.1 but no agent requirements outlined. College will respond through an additional addendum.
Question: Response:	No specifications for analog phones such as FAX, ATM or alarms. College will respond through an additional addendum.
Question: Response:	No specifications for disaster recovery or alternate routing. College will respond through an additional addendum.
Question: Response:	Is the College interested in a Premise Based solution Vs Hosted Based Solution? College will respond through an additional addendum.
Question: Response:	Is the College more interested in a Capex vs. Opex solution? College will respond through an additional addendum.
