CARES Act Institutional Emergency Funds**

Pensacola State College has received institutional emergency relief funds following policies and procedures for the Institutional Portion of the Higher Education Emergency Relief Fund Formula Grants Authorized by Section 18004(a)(1) of the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The CARES Act, which establishes and funds the Higher Education Emergency Relief Fund (HEERF),

directs institutions of higher education to use up to 50 percent of funds received under Section 18004(c) of the CARES Act to cover any costs associated with significant changes to the delivery of instruction due to the coronavirus.
